# RESOLUTION NO. \_\_\_\_\_ 2020 -2-12-(001)

## A RESOLUTION IN SUPPORT OF THE RIGHT TO KEEP AND BEAR ARMS

WHEREAS, the Second Amendment to the United States Constitution guarantees the "right of the people to keep and bear arms, shall not be infringed"; and,

WHEREAS, Article I §32 of the Indiana Constitution provides: "people shall have the right to bear arms, for the defense of themselves and the State"; and,

WHEREAS, the United States Supreme Court has held that the Second Amendment to United States Constitution applies to the states; and,

WHEREAS, the United States Supreme Court has recognized, subject to certain limitations, that individuals have a right to own and possess firearms for self-defense and other lawful purposes; and,

WHEREAS, the members of the Board of Commissioners of Henry County, Indiana ("Board") have taken an oath to defend and uphold the Constitution of the United States and the Constitution of the State of Indiana; and,

WHEREAS, the Board believes that the right of citizens to keep and bear arms is a fundamental right that should be protected; and,

WHEREAS, the Board wishes to express its opposition to any law that would unconstitutionally restrict the rights of law abiding citizens of Henry County, Indiana to keep and bear arms; and,

WHEREAS, the Board wishes to act in the best interests of the citizens of Henry County with regard to this important and fundamental right.

#### NOW THEREFORE BE IT RESOLVED:

1. The Board hereby declares Henry County a "Constitutional County" and expresses its continued commitment to support all provisions of the Constitution of the United States and the Constitution of the State of Indiana, including the right of people to keep and bear arms; and,

2. The Board expresses its strong support for the rights of law abiding Henry County citizens to keep and bear arms.

3. This resolution shall become effective upon its approval.

All of which is resolved by the Board of Commissioners of Henry County, Indiana this 12 day of Flay, 2020.

# ORDINANCE NO. <u>2020 - 1 - 2 - 11</u>

## AN ORDINANCE AUTHORIZING DEPOSIT OF FUNDS IN COUNTY AUCTION FUND

WHEREAS, Henry County has previously established an Auction Fund for the deposit of proceeds from the sale of County owned property and equipment; and,

WHEREAS, on August 17, 2019, Henry County sold, by public auction, certain items of surplus personal property; and,

WHEREAS, the proceeds from the sale are required to be deposited into the County's Auction Fund.

NOW THEREFORE BE IT ORDAINED as follows:

1. The proceeds from the auction sale of surplus personal property on August 17, 2019, shall be deposited into the County's Auction Fund;

2. The proceeds from the sale shall be appropriated and expended in accordance with applicable law.

<u>EFFECTIVE DATE</u>: This Ordinance shall become effective immediately upon passage by the Board of Commissioners of Henry County.

<u>SEVERABILITY</u>: Any provision contained in this ordinance, which is found by a court of competent jurisdiction to be unlawful, or by operation of law, including subsequent legislative enactment, is rendered inapplicable, shall be omitted and the rest and remainder of this ordinance shall remain in full force and effect.

<u>REPEALER</u>: All ordinances that are in conflict with the terms of this Ordinance are hereby repealed as of the effective date of this Ordinance.
