The meeting was opened with the Pledge and a Prayer given by Steve Dellinger.

A motion was made by Bobbi Plummer and seconded by Joe Wiley to approve the minutes of the October 11, 2023 meeting. Motion carried unanimously.

A motion was made by Bobbi Plummer and seconded by Joe Wiley to approve claims as presented. Motion carried unanimously.

A motion was made by Bobbi Plummer and seconded by Joe Wiley to approve payroll as presented. Motion carried unanimously.

A motion was made by Bobbie Plummer and seconded by Joe Wiley to approve the monthly reports for the Clerk and Weights & Measurers. Motion carried unanimously.

A motion was made by Bobbi Plummer and seconded by Joe Wiley to write a letter of support to Delaware County for the Mental Health Facility Grant Application. Motion carried unanimously.

A motion was made by Bobbi Plummer and seconded by Joe Wiley to approve the quote for 40th Parallel Surveying for the Topographical Survey of the Courthouse in the amount of \$7,778.00, and Mason Private Location in the amount of \$2,925.00. Motion carried unanimously.

Angela Cox information the Commissioners they are hoping to get the Coalition Coordination hired and make the announcement of Monday. She also still has a concern with the west end of the Henry County Office Building being repaired.

Commissioner Dellinger asked for clarification on if the Sheriff Department was going to bid fuel on his own and not with the City of New Castle, EMS, Coroner and Community Corrections. Sheriff explained that it is an accounting issue billing the other agencies. The Sheriff would like to have each agency individualized in the billing.

Sheriff Sproles and Matt Pierce talked with the Commissioners about leasing of vehicles with Enterprise. Four cars would be \$57,000 roughly. The traditional financing for four years is \$68,800 on four vehicles. Cars purchased from Hamilton County will be a huge help with the car problem at the Sheriff's Department. He would like to do the lease because he is being a fleet manager and he is a captain and this is taking away from his other jobs. Enterprise also has a matrix system to let them know if someone has gone over on oil or if the tires need to be changed. With these they will receive the factory warranty, and they have several place they will be able to use for oil changes and repairs.
