CALL FOR PROJECTS - DUE JULY 30, 2021

Our region, consisting of **Blackford, Delaware, Grant, Henry, Jay, Randolph, and Wayne Counties**, has endless opportunities for individuals and businesses to build a life and make a difference. While we have numerous advantages on our side, we believe we can be stronger. We believe that by working together we can establish our region as a destination and a place where people want to live, work, and play.

The [East Central Indiana Regional Partnership](#) (ECIRP), in partnership with local governments, economic development organizations and anchor institutions, is in the process of preparing a Regional Development Plan. The [Forge Your Path](#) strategy, the region’s most recent collaborative strategy to develop a robust and dynamic regional talent pool, will continue to serve as the region’s collective identity. However, this regional process will also allow us to identify strategic projects and programs that strengthen our communities and make East Central Indiana a competitive choice for talent and prosperity.

When complete, ECIRP will use the Plan to apply for up to \$50 million in funding to accelerate the implementation of regional projects and programs through [Indiana’s READI program](#). To ensure that our Regional Development Plan includes initiatives that represent all areas of our diverse region, we are collecting project submissions through this Call for Projects.

Any projects who wish to request funding may submit a Submission Form. A separate form must be completed for each project. Not every project or proposal submitted will be incorporated into the regional development plan. Inclusion in the plan does not guarantee that the project/program will be READI fundable.

The information you provide will help inform the region’s long-term strategic plan and we encourage you to think big. The ECIRP planning team will review all submissions to determine which projects will be included in the final grant submission to the State of Indiana, which is due August 31, 2021. If the region is selected for READI, a funding committee will be established to prioritize and distribute grant dollars.

We understand that the timeline is short but as a region we must move quickly to meet the state’s timeline. Please complete and submit this form as soon as practical but not later than July 30, 2021.

The READI program can be used to fund physical projects and sustainable, multi-year programs that will improve our region's ability to support existing residents and business, attract new talent, industries and put east central Indiana on the map as a regional destination.

For the purposes of our process projects and programs can be defined as:

Capital improvement (built construction) projects may include construction and physical quality of place assets including but not limited to workforce housing developments, industry development/expansion, infrastructure, redevelopment projects, innovative spaces dedicated to industry-driven partnerships, and cultural amenities. All capital improvements plans must meet universal design and other ADA accessibility requirements.

Strategic programs may include, but are not limited to, initiatives intended to support talent development needs, programs that enhance and improve opportunities for hard-to-employ populations, quality of life strategies such as public health and community development, and/or public-private partnerships and small business support services.

Hybrid projects are those that include a programmatic component or a program that requires a project investment.
